Deputy Director Stein stated the Village will be moving the water conservation status to the "Yellow" condition on July 3rd due to current drought conditions. He also stated Water Tower #4 will be taken offline in order to accommodate the tower painting project and is scheduled to start in July. This may cause temporary water pressure changes for certain areas of the Village during the 60-day estimated project timeline.

Economic Development Specialist Gardner provided an overview of the Innovative Commerce Serving Communities (ICSC) event he attended and discussed economic development trends. Economic Development Specialist Gardner also discussed his work regarding the potential Central Cary TIF District and Maplewood property.
