Motion: **I will entertain a motion to approve an ordinance designating the Village of Cary Central Cary Tax Increment Financing District (TIF District #3) Redevelopment Project Area.**

Introduction

In June 2022, the Village of Cary began reviewing the potential creation of a new Central Cary Tax Increment Financing District (TIF District #3) to assist with economic development initiatives within the Village. The Village has adhered to the requirements of the Tax Increment Allocation Redevelopment Act (TIF Act) in implementing this new district including holding various public meetings, performing plans and studies, distributing various notices, and convening of a Joint Review Board of the affected taxing districts.

Following the adoption of the TIF Plan by ordinance, a second ordinance must be approved by the Village Board which formally designates the limits of the Central Cary Tax Increment Financing District (TIF District #3) and the subject parcels that will be included within its jurisdiction. The attached ordinance will formally create the proposed TIF District #3.

WHEREAS, pursuant to the Tax Increment Allocation Redevelopment Act, 65 ILCS 5/11-74.4-1 *et seq.* (hereinafter referred to as the "TIF Act"), the Village of Cary (hereinafter referred to as the "Village") authorized a study in regard to designating a redevelopment project area for the Village's Central Cary Tax Increment Financing District (TIF District #3) (hereinafter referred to as the "TIF District"); and

WHEREAS, on May 2, 2023, the Village announced the availability of the redevelopment plan and project for the TIF District (hereinafter referred to as the "TIF Plan"), with said TIF Plan containing an eligibility study for the TIF District addressing the tax increment financing eligibility of the area proposed for designation as the redevelopment project area for said TIF District (hereinafter referred to as the "Redevelopment Project Area"), and a housing impact study for the TIF District; and

WHEREAS, the Mayor and Board of Trustees of the Village have heretofore adopted and approved the TIF Plan, with respect to which a public hearing was held on July 18, 2023, and it is now necessary and desirable to designate the area referred to therein as the Redevelopment Project Area;

NOW, THEREFORE, BE IT ORDAINED, by the Mayor and Board of Trustees of the Village of Cary, McHenry County, Illinois, as follows:

SECTION 1: That the Recitals, as set forth above, are incorporated herein by reference and made part hereof.

SECTION 2: That the area described and depicted in EXHIBIT A-1 and EXHIBIT A-2 attached hereto, and made a part thereof, is hereby designated as the Redevelopment Project Area for the Village's Central Cary Tax Increment Financing District (TIF District #3) pursuant to Section 5/11-74.4-4 of the TIF Act (65 ILCS 5/11-74.4-4).

SECTION 3: That all ordinances or parts of ordinances in conflict with this Ordinance are hereby repealed to the extent of such conflict.

SECTION 4: That if any part or parts of this Ordinance shall be held invalid for any reason, such decision shall not affect the validity of the remaining part or parts of this Ordinance.

SECTION 5: That this Ordinance shall be in full force and effect from and after its passage, approval and publication in pamphlet form as provided by law.

CENTRAL CARY TIF DISTRICT (TIF DISTRICT #3) LEGAL DESCRIPTION

THAT PART OF SECTION 18, TOWNSHIP 43 NORTH, RANGE 9 EAST, SECTION 13 AND THE SOUTH HALF OF SECTION 12, TOWNSHIP 43 NORTH, RANGE 8 EAST OF THE THIRD PRINCIPAL MERIDIAN IN MCHENRY COUNTY, ILLINOIS, BEING DESCRIBED AS FOLLOWS:

BEGINNING AT THE POINT OF INTERSECTION OF THE SOUTH RIGHT-OF-WAY LINE OF JAMES WAY AND THE NORTHEASTERLY RIGHT-OF-WAY LINE OF SILVER LAKE ROAD;

THENCE NORTH ALONG SAID WEST TERMINUS OF WEBER COURT TO A POINT ON THE NORTH RIGHT-OF-WAY LINE OF SAID WEBER COURT;

THENCE EAST ALONG SAID NORTH RIGHT-OF-WAY LINE OF SAID WEBER COURT TO A POINT ON THE EAST LINE OF THE SOUTHWEST QUARTER OF THE SOUTHEAST QUARTER OF SAID SECTION 12;

THENCE SOUTH ALONG SAID EAST LINE OF THE SOUTHWEST QUARTER OF THE SOUTHEAST QUARTER OF SECTION 12 TO THE SOUTHEAST CORNER THEREOF, SAID SOUTHEAST CORNER ALSO BEING THE NORTHEAST CORNER OF THE NORTHWEST QUARTER OF THE NORTHEAST QUARTER OF SAID SECTION 13;

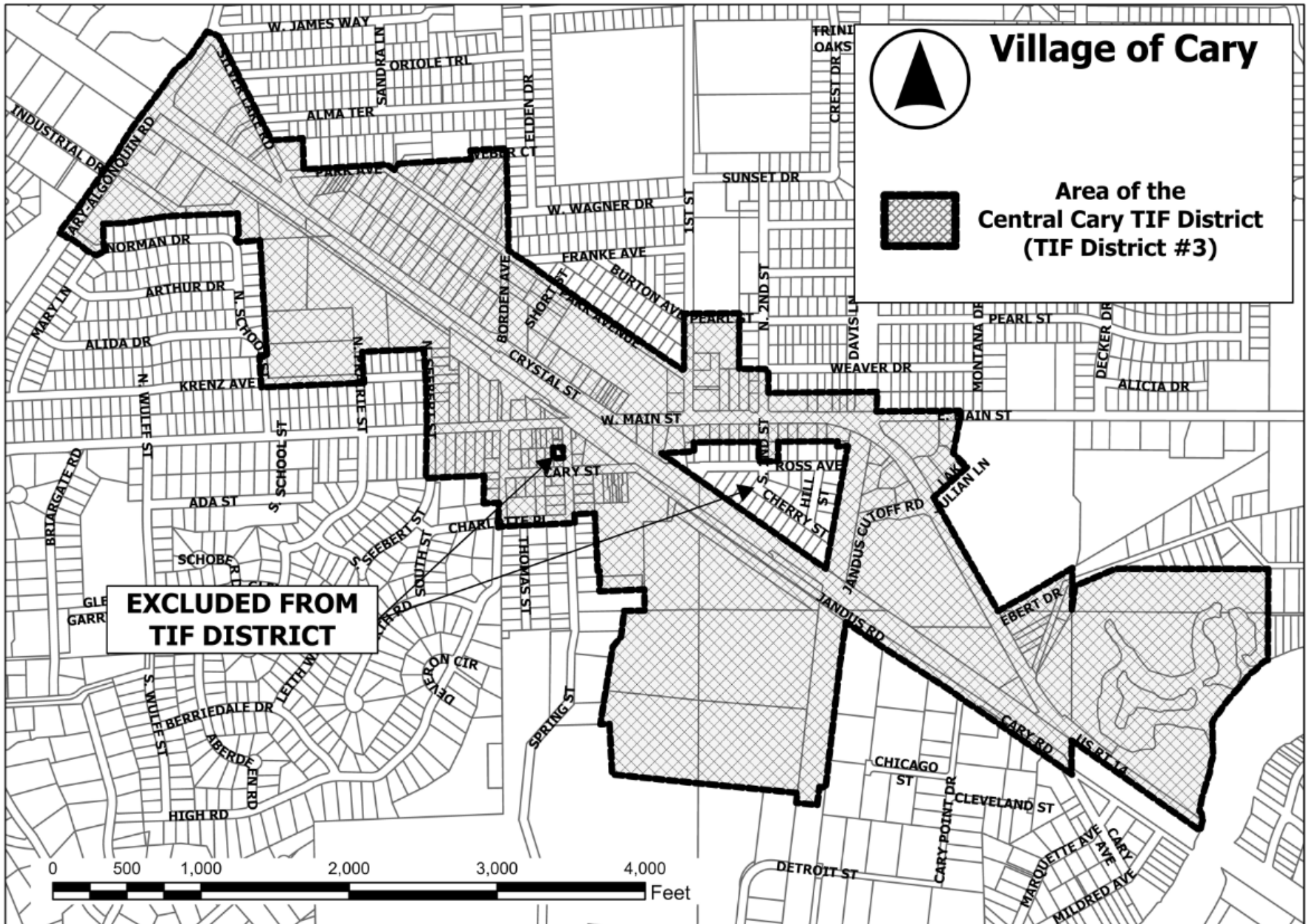


Exhibit A-2 Village of Cary Central Cary Tax Increment Financing District (TIF District #3)
